To opt-out of solid waste services provided by Kimble Recycling & Disposal Inc., through agreement with Hinckley Township, I hereby file this affidavit stating such. ***PLEASE NOTE: Affidavits must be submitted, reviewed and approved annually.*** Hinckley Township will use its best efforts to review this form, and approval will be determined on a case-by-case basis subject to the conditions outlined below and in the contract.

For service beginning February 2022, opt-out affidavits will be made available September, 2021. Official submission however will begin at 9:00 a.m. November 1, 2021 and end at 12:00 p.m. November 3, 2021. ***PLEASE NOTE: In order to have a safer, simpler and more efficient process, submissions will be accepted via Email only.*** No postal service or in-person drop off will be accepted. Forms must be completed in entirety. Please feel free to contact the Township should you have any questions regarding completion of the form. Affidavits will be processed on a first come, first serve basis. Hinckley Township’s Email receipt date and time will determine order.
